## 3. Purposes and legal bases of the processing

### 3.a. Purpose of the processing:

Your data is collected in order to

- address scientific research questions regarding password security behavior (university research purpose).
- make scientific publications based on the findings from the processing of the data.

### 3.b. Legal bases of the processing

Your data is processed based on Art. 6 Abs. 1 a, Art. 7, Art. 9 Abs. 2 a, Art. 89, Art. 156 und Art 159 DSGVO and Art. 25 BayDSG processed.

## 4. Recipients or categories of recipients of the personal data

The data collected from you (except email) will be processed for research and development purposes at the Bundeswehr University Munich.

## 5. Dauer der Speicherung der personenbezogenen Daten

The deletion of your contact data (email address) is carried out in accordance with the principles of research on humans of the German Research Foundation (DFG). These personal data will be deleted as soon as they are no longer needed for the recruitment of subjects or for follow-up inquiries.

The remaining data collected from you will be stored anonymously and *will not be deleted* after the processing and evaluation.

## 6. Data subject rights

According to the General Data Protection Regulation, you have the following rights:

If your personal data is processed, you have the right to receive information about the data stored about you (Art. 15 DSGVO).

If incorrect personal data is processed, you have the right to rectification (Art. 16 DSGVO).

If the legal requirements are met, you may request erasure or restriction of processing as well as object to processing (Art. 17, 18 and 21 DSGVO).

If you have consented to the data processing or if a contract for data processing exists and the data processing is carried out with the help of automated procedures, you may have a right to data portability (Art. 20 DSGVO).

Should you make use of your above-mentioned rights, the public body will check whether the legal requirements for this are met.

Furthermore, you have the right to lodge a complaint with the Bavarian State Commissioner for Data Protection.
